



# **ACTS 15:6-11**

"THE DEBATE"

JUNE 2, 2024

#### SUMMARY

This week, Pastor Jeff continued our discussion on the debate between Jewish believers about the requirements for Gentile believers to be saved. Some Jewish believers claimed that faith alone was not sufficient to be saved but that they must also become Jews by obeying the Mosaic law. Others, rightly understanding the teachings of Jesus' new covenant, fiercely defended the finished work of the cross that freed us from the law. This debate was of supreme importance then and is no less important today.

Based on Peter's words in Acts 15, Pastor Jeff instructed us that Gospel Clarity = Gospel Charity. The law is meant to show us our sin but cannot free us from it. Only the cross can do that. And because of the Cross, we now remove the burden of legalism from the necks of those seeking Jesus so they may hear the good news of Jesus clearly and be saved.

Pastor Jeff challenged us to investigate our lives as we are all prone to believe that our culture is not just something we like but is right. And when we do that, we add those cultural expectations as requirements that pollute the power of the Gospel. In reality, as individuals changed by the freeing power of the Gospel, we must defend its clarity so we can extend Gospel Charity to a spiritually hungry and lost world.
